Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, half round band of 2.98mm width (at base) x 2.08mm depth, with a curved undertrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the shoulders of the plain and polished band. Each shoulder houses one row of five round brilliant cut diamonds, bead set.

Polished finish.

Stamped '750 BW 01' - acid tested as 18 carat gold.

Ring size: J.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "G+".

Dimensions = 4.71mm(L) x 4.69mm(W) x 3.10mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.43ct (estimated - see NOTE below)

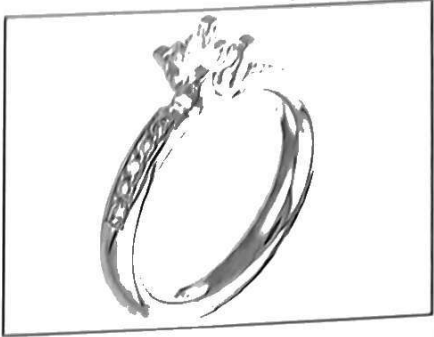
Ten bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 4.51 grams Total Gemstone Weight = 0.53ct Total Metal Weight = 4.40 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
