Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct yellow gold and 9ct white gold, gem set, necklet.

Feature yellow gold and white gold, 'cluster' style setting, housing nine round brilliant cut diamonds, largest to the centre, all claw set. Articulated from the bail assembly.

The chain being of a 'curb' style, 'figaro+3' linkage design, with a small 'bolt' ring type clasp fitted.

Polished finish.

Stamped '375 JP88' (on pendant), '375 ITALY JP4' (on chain) - acid tested.

Chain dimensions = 45.00cm (length including clasp) x 1.23mm (ave. width) x 0.59mm (ave. depth).

The necklet contains:

Nine claw set round brilliant cut diamonds, clarity 'Si', colour 'H to I' (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.13ct (estimated - see NOTE below)

Total Item Weight = 1.95 grams

Total Gemstone Weight = 0.13ct

Total Metal Weight = 1.92 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
