Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and rhodium plated, gem set, multistone ring, of cast construction.

Plain, wide, low half round, tapered band of 6.88mm width (at base) x 0.99mm depth, with a hollow top and shoulders, and open back settings.

Feature square top plate, housing one row of three round brilliant cut diamonds, across one corner, and channel set. The top plate, gallery and shoulders, are embellished with a 'paved' style texture. The top plate is secured between the tapering shoulders of the plain and polished band. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped '14K' - acid tested as 14 carat gold.

Ring size: P.

The ring contains:

Three channel set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 3.66mm(Dia) x 2.23mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.80mm(Dia) x 2.32mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.57ct (estimated - see NOTE below)

Total Item Weight = 10.32 grams

Total Gemstone Weight = 0.57ct

Total Metal Weight = 10.21 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
