Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.84mm width (at base) x 1.48mm depth.

Feature central four claw setting, housing one emerald cut synthetic moissanite, claw set. The setting and shoulders houses a total of one hundred and four round synthetic moissanite, slightly varying in size, and claw set. The central setting is secured between the shoulders of the plain and polished band.

Polished finish.

Stamped 'AU750' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

One claw set emerald cut synthetic moissanite, colour is "colourless".

Dimensions = 9.13mm(L) x 7.12mm(W) x 4.34mm(D-estimated)

Total Weight = 2.23ct (estimated - see NOTE below)

One Hundred And Four claw set round synthetic moissanites, colour is "colourless".

Dimensions = 1.10mm - 1.00mm x 0.61mm(D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 3.01 grams Total Gemstone Weight = 2.75ct Total Metal Weight = 2.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
