### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 10ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.55mm width (at base) x 1.54mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature rectangle top plate, housing one central inner diagonal row of five round brilliant cut diamonds, and two outer rows of four round brilliant cut diamonds, slightly varying in size, and all channel set. The top plate is secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '10K michael hill 0.50 TDW' - acid tested as approximately 10 carat gold.

Ring size: X.

The ring contains:

Thirteen channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 8.65 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 8.55 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
