Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.22mm width (at base) x 1.64mm depth, with open back settings.

Feature 'cross over' style ring, tapering band with one termination folding over the other, in the centre of the band. There are three bezel settings, spanning across the top of the band, one housing one round brilliant cut diamond, the other two each housing one old cut diamond. The diamonds graduate in size, and are bezel set. The shoulders are embellished with 'strap' detail.



Polished finish. Stamped '750' - acid tested as 18 carat gold. Ring size: M.

The ring contains:

One bezel set round brilliant cut diamond, clarity is "Si1", colour is "J".

Dimensions = 3.84mm(L) x 3.82mm(W) x 1.98mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

One bezel set old cut diamond, clarity is "P1", colour is "I".

Dimensions = 3.20mm(L) x 3.16mm(W) x 2.16mm(D-estimated)

Total Weight = 0.14ct (estimated - see NOTE below)

One bezel set old cut diamond, clarity is "P1", colour is "H".

Dimensions = 2.90mm(L) x 2.85mm(W) x 1.70mm(D-estimated)

Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 8.70 grams Total Gemstone Weight = 0.41ct Total Metal Weight = 8.62 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
