## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, 'solitaire' style dress ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.88mm width (at base) x 0.96mm depth, with an open back setting, and a curved underrail.

Feature central white gold square top plate, housing one round brilliant cut diamond, claw set. The top plate is secured to the underrail, and in between the dished and rounded shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '18ct' - acid tested as 18 carat gold.

Ring size: R 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".

Dimensions = 4.03mm(L) x 4.01mm(W) x 2.46mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 7.05 grams

Total Gemstone Weight = 0.25ct

Total Metal Weight = 7.00 grams (estimated)



NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
