### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, platinum, gem set, 'solitaire' style ring, of cast construction.

Plain, narrow, half round band of 1.77mm width (at base) x 1.10mm depth.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the top of the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped 'COO PLAT 950 michael hill 030002309938' - acid tested as platinum.

Ring size: I 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "G".  
Dimensions = 7.26mm(L) x 7.23mm(W) x 4.41mm(D-estimated) x 3%(Girdle Thickness)  
Total Weight = 1.43ct (estimated - see NOTE below)

Total Item Weight = 3.44 grams  
Total Gemstone Weight = 1.43ct  
Total Metal Weight = 3.15 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
