One, 10ct yellow gold, gem set, multistone ring, of cast construction.

Plain, wide, low half round, tapered band of 4.25mm width (at base) x 1.61mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature four rows, housing a total of sixty-six round brilliant cut diamonds, spanning across the top of the band. The diamonds vary in size, and graduate slightly down the shoulders, pave set. The top plate is secured between the tapering shoulders, of the plain and polished band.
