Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled raised sterling silver & gemset, flexible link pendant/necklet.

Feature; "drop style" pendant/necklet. Comprising, a drop style rub-over setting, with a v-shaped bail attached to top, houses one oval-shaped, faceted sapphire, rub-over set. Suspended from a medium curb linked chain in silver, with a parrot clasp closure attached.

Polished finish, stamped "925, JC" - acid tested as silver.

Necklet/pendant dimensions = 71.00cm (L) x 2.06mm (W) x 1.23mm (depth).

The pendant contains:

- One rub-over set oval-shaped, natural sapphire, colour is "dark blue".
- Dimensions = 13.00mm (L) x 11.60mm (W) x 6.35mm (D-estimated)
- Total Weight = 7.69ct (estimated - see NOTE below).

Total Item Weight = 13.10 grams, Total Gemstone Weight = 7.69ct, Total Metal Weight = 11.56 grams (estimated)

NOTE: Limited gemmological testing, inset. The pendant appears to be a mixed white metal silver & nickel, the sapphire, appears to possibly be dyed, & would require unsetting for full gemmological testing, by the Australian Gem Testing Laboratory for verification. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. The below replacement figure is based upon crafting a similar pendant/necklet combination, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
