Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and rhodium plated, gem set, multistone ring, of cast construction.

Plain, narrow, high half round, tapered band of 1.94mm width (at base) x 1.29mm depth, with open back settings, and a curved underrail.

Feature three decorative claw settings, spanning across the top of the band, each housing one oval natural aquamarine, graduating in size, largest to the centre, claw set. There are four, three claw settings, separating the larger stones, each housing one round brilliant cut diamond, claw set. The settings are supported with a decorative gallery, and are secured between the pierced tapering shoulders, of the plain and polished band.



Polished finish. Stamped '585 S 6.77ct D 0.17ct' - acid tested as 14 carat gold. Ring size: O 1/2.

The ring contains:

One claw set oval shaped natural aquamarine, colour is "blue".
Dimensions = 11.15mm(L) x 8.70mm(W) x 6.22mm(D-estimated)
Total Weight = 3.50ct (estimated - see NOTE below)

Two claw set oval shaped natural aquamarines, colour is "blue".
Dimensions (average) = 8.95mm(L) x 6.98mm(W) x 4.25mm(D-estimated)
Total Weight = 3.27ct (estimated - see NOTE below)

Four claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).
Dimensions (average) = 2.25mm(Dia) x 1.37mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.17ct (estimated - see NOTE below)

Total Item Weight = 6.34 grams Total Gemstone Weight = 6.94ct Total Metal Weight = 4.95 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
