Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.83mm width (at base) x 1.34mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central four claw setting, housing one Princess cut diamond, claw set. Either side of the central setting, is three shared claw settings, each housing one round brilliant cut diamond, claw set. The settings are secured between the extended and pointed shoulders, in a 'wrap around' style, of the plain and polished band. Each of the shoulders houses one row of seventeen round brilliant cut diamonds, claw set.

Polished finish.

Stamped '585 D0.56ct' - acid tested as 14 carat gold.

Ring size: M 1/2.

The ring contains:

One claw set Princess cut diamond, clarity is "Si1", colour is "H".

Dimensions = 3.80mm(L) x 3.59mm(W) x 2.61mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Forty claw set round brilliant cut diamonds, clarity is "Si & P1 & P2 & P3" (mixed), colour is "I to K" (mixed).

Dimensions = 1.01mm(Dia) x 0.62mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.62mm(Dia) x 0.99mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 2.61 grams Total Gemstone Weight = 0.56ct Total Metal Weight = 2.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
