## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.86mm width (at base) x 1.05mm depth, with open back settings.

Feature central bezel setting, housing one marquise diamond, bezel set. The setting is secured between the shoulders of the plain and polished band. Each of the shoulders houses two rows of three round brilliant cut diamonds, slightly graduating in size, and channel set.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: H 1/2.

The ring contains:

One bezel set marquise cut diamond, clarity is "Si2", colour is "G".

Dimensions = 8.09mm(L) x 4.32mm(W) x 2.66mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.55ct (estimated - see NOTE below)

Twelve channel set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions = 2.06mm(Dia) x 1.26mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.18mm(Dia) x 1.33mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.45ct (estimated - see NOTE below)



Total Item Weight = 5.75 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.56 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
