Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised platinum & diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures, 1.94mm width (at base) 1.98mm depth, with curved underrail.

Feature; "Solitaire style" ring design. Comprising, a raised six claw setting, housing one round brilliant cut diamond, (laser inscribed T&Co D08020923 on the upper star facet), claw set. The extended shoulders, of the band tapers up to a pyramid profile termination, to both sides.

Polished finish, stamped "(C) Tiffany & Co, PT 950, 32174299 D0.94" - acid tested as platinum.

Finger size = L.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Vs", colour is "G", good cut quality.
Dimensions = 6.24mm (average diameter) x 3.81mm (D-estimated) x 2.5%(Girdle Thickness)
Total Weight = 0.94ct (estimated - see NOTE below).

Total Item Weight = 5.91 grams, Total Gemstone Weight = 0.94ct, Total Metal Weight = 5.72 grams (estimated)

NOTE: Limited gemmological testing, inset. However to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The ring has a stamp of Tiffany & Co upon - however, Tiffany in Melbourne will not assist with help in authenticating whether or not the ring is of their supply. Therefore, the below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
