Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled raised, 18ct yellow gold & diamond set, cross pendant.

Feature; "block style cross" drop pendant. Housing six round brilliant cut diamonds, rub-over set, flush to the gold. Open back settings, underneath, the cross is suspended from a rounded edge rectangular shaped bail, articulated at the top.

Polished finish, stamped "18ct" - acid tested as 18 carat gold.

Cross/pendant dimensions = 41.00mm (L) x 25.00mm (W) x 2.24mm (D).

The cross/pendant contains:

One rub-over set round brilliant cut diamond, clarity is "Vs", colour is "G", medium cut quality.
Dimensions = 3.40mm (average diameter) x 2.07mm (D-estimated)
Total Weight = 0.15ct (estimated - see NOTE below).

Five rub-over set round brilliant cut diamonds, clarity is "Vs, Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 3.20mm (average diameter) x 1.95mm (D-estimated)
Total Weight = 0.60ct (estimated - see NOTE below).

Total Item Weight = 10.43 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 10.28 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar cross/pendant combo employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
