Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's raised 14ct rose gold & gemset, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.15mm width (at base) x 1.27mm depth, with curved underrail, open back settings, underneath.

Feature; "cluster rows" style run across the top of the band. Comprising, five cluster settings, Each contain, one oval-shaped, faceted, pink sapphires, claw set. surrounded by a total of seventy five round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up to the top of the ring, from both sides.



Polished finish, stamped "585, S2.27ct, D0.39ct" - acid tested as 14 carat gold. Finger size = M.

The ring contains;

Five claw set oval-shaped, natural sapphires, colour is "medium pink".

Average dimensions = 5.87mm (L) x 4.05mm (W) x 1.84mm (D-estimated) (smallest)

Average dimensions = 6.10mm (L) x 4.15mm (W) x 2.07mm (D-estimated) (largest)

Total Weight = 2.27ct (estimated - see NOTE below).

Seventy Five claw set round brilliant cut diamonds, clarity is "P1, P2 & P3" (mixed), colour is "H to J" (mixed), medium cut quality.

Dimensions = 0.80mm (average diameter) x 0.49mm (D-estimated) (smallest)

Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated) (largest)

Total Weight = 0.39ct (estimated - see NOTE below).

Total Item Weight = 3.86 grams, Total Gemstone Weight = 2.38ct, Total Metal Weight = 3.32 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
