## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.20mm width (at base) x 0.99mm depth.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the tapering shoulders, of the plain and polished band. Each of the shoulders houses one row of three single cut diamonds, graduating in size, and claw set.

Polished finish.

Stamped '10ct(partial stamp) PALAD' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".

Dimensions = 4.57mm(L) x 4.52mm(W) x 2.80mm(D-estimated) x 1.5%(Girdle Thickness)

Total Weight = 0.36ct (estimated - see NOTE below)

Six claw set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to I" (mixed).

Dimensions = 1.35mm (diameter) (smallest)

Dimensions = 1.70mm (diameter) (largest)

Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 1.86 grams Total Gemstone Weight = 0.45ct Total Metal Weight = 1.77 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
