One cast 9k vellow gold triple cluster multi-stone diamond ring, plain flat profile tapered shank of width 3.95mm - 2.31mm x 1.25mm. The ring consisting of 19 x claw set round brilliant cut diamonds in triple cluster, 22 x pave set round brilliant cut diamonds and 20 channel set baguette cut & tapered baguette cut diamonds on diagonally up-swept shoulders, polished finish and stamped 9k - 1.00.

41 x round brilliant cut diamonds, colour = I - I, clarity = P, estimated. Dimensions = 2.10mm – 1.00mm, average diameter. Weight = 0.80ct estimated.

20 x baguette cut and tapered baguette cut diamonds, colour = H - J, clarity =P, estimated.

Dimensions = $2.00 \times 1.00 \text{mm} - 2.00 \times 0.50 \text{mm}$, average. Weight = 0.20ct estimated.
