

One hand assembled 14k white gold treated blue diamond and white diamond ring, plain flat profile tapered shank of width 3.01mm – 2.31mm x 1.09mm. Centre set with round brilliant cut diamond in a "4" claw coronet, lower 16 x pave' set round brilliant cut diamond surround, 2 x rub-over set round brilliant cut diamonds, 30 x pave' set round brilliant cut diamonds on either side of the split and flared up-swept shoulders and 2 x grain set round brilliant cut diamonds on either side way of the coronet, polished finish and stamped 14k – HJ Namdar.

01 x round brilliant cut diamond, colour = treated blue, clarity = SI2, estimated. Dimensions = 4.98 x 4.96 x 3.04mm, average. Weight = 0.47ct estimated.



Total Item Weight = 4.50gm estimated. Total Gem Weight = 0.75ct estimated.



Note: The below replacement figure is based up-on local current market price in present condition. 2 x diamonds are missing, Initial gemmological tests indicate colour enhance diamond, assuming from natural origin, accurate identification requires removal of the stone to verify origin of material, from the setting for further gemmological testing.
