Dimensions = 5.10 x 5.00 x 3.17mm.  
Weight = 0.50ct estimated.

05 x round brilliant cut diamonds, colour = G – I, clarity = SI, estimated.  
Dimensions = 1.50mm – 1.40mm, average diameter. Weight = 0.06ct estimated.

03 x round brilliant cut diamonds, colour = enhanced green, clarity = SI, estimated.  
Dimensions = 1.50mm, average diameter. Weight = 0.04ct estimated.

03 x round brilliant cut diamonds, colour = enhanced blue, clarity = SI, estimated.  
Dimensions = 1.50mm, average diameter. Weight = 0.04ct estimated.

05 x round brilliant cut diamonds, colour = enhanced yellow, clarity = SI, estimated.  
Dimensions = 1.60mm, average diameter. Weight = 0.08ct estimated.

Total Item Weight = 8.60gm estimated.  
Total Gem Weight = 0.72ct estimated.
