Centre set with round brilliant cut diamond in a “4” claw coronet, lower 32 x pave’ set round brilliant cut diamonds surround and total of 12 x pave’ set round brilliant cut diamonds on either side of the slightly extended shoulders with contoured under-rail, 22k yellow gold floral motif under bezel, polished finish and stamped 22k – 18k Michael hill 0.50.
