Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 18ct yellow and white gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 2.79mm width (at base) x 1.03mm depth, with open back, underneath.

Feature, "navette shaped cluster" style setting, in white gold, housing nine round brilliant cut diamonds, various sizes, claw set. The extended shoulders, of the yellow gold band, tapers up to pointed end terminations, to both sides.

Polished finish, stamped "18K, 750" - acid tested as 18 carat gold.

Finger size = N.

The ring contains;

Nine claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.04mm (average diameter) x 1.24mm (D-estimated) (smallest)

Dimensions = 3.20mm (average diameter) x 1.95mm (D-estimated) (largest)

Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 3.10 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 3.04 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
