Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 14ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.03mm width (at base) x 1.14mm depth, tapers up to 12.73mm width (at top), with cut-out underrail.

Feature, "wide dress style" cluster. Comprising a raised seven row across the top of the band, housing ninety one round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up wide to the top, from both sides.

Polished finish, stamped "14K, MHJ" - acid tested as 14 carat gold.

Finger size = N1/2.

The ring contains;

Ninety One claw set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.50mm (average diameter) x 0.98mm (D-estimated) (smallest)
Dimensions = 1.80mm (average diameter) x 1.10mm (D-estimated) (largest)
Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 7.60 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 7.42 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
