Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct gold, gem set, multistone ring, of cast construction.

Plain narrow, low half round band of 2.61mm width (at base) x 1.03mm depth, with closed back settings.

Feature one row of thirteen round brilliant cut diamonds, and one round cut synthetic cubic zirconia, spanning across the top of the band. The diamonds are slightly graduating in size, largest to the centre, and bead set. The settings are framed with millegrain detail.



Polished finish.

Incorrect stamp '18CT' - x-rayed as approximately 14 carat gold (mixed metals).

Ring size: P.

The ring contains:

Thirteen bead set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 2.15mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.55ct (estimated - see NOTE below)

One bead set round synthetic cubic zirconia, colour is "colourless".

Dimensions = 2.15mm(Dia) x 1.31mm(D-estimated)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 3.10 grams Total Gemstone Weight = 0.61ct Total Metal Weight = 2.98 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
