## Valuation for Traditional Retail Insurance Replacement

## Item 1

One lady's, raised 18ct white gold & diamond set, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.05mm width (at base) x 1.14mm depth, with curved underrail.

Feature, "single row style" ring design. Comprising, a channel row runs across the top of the band. Alternating diamonds, channel set. The extended shoulders, of the band tapers up to the top, from both sides.

Polished finish, stamped "750, 0.50, MHJ" - acid tested as 18 carat gold. Finger size = O1/2.



The ring contains;

Seven channel set Princess cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality. Average dimensions = 2.00mm (L) x 1.90mm (W) x 1.35mm (D-estimated)

Total Weight = 0.28ct (estimated - see NOTE below).

Eight channel set baguette diamonds, clarity is "Si & P1" (mixed), colour is "G to I" (mixed), medium cut quality.

Average dimensions = 1.80mm (L) x 1.20mm (W) x 0.88mm (D-estimated) (smallest)

Average dimensions = 2.00mm (L) x 1.30mm (W) x 0.95mm (D-estimated) (largest)

Total Weight = 0.22ct (estimated - see NOTE below)

Total Item Weight = 3.40 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 3.30 grams (estimated)

NOTE: Limited germological testing, inset. Due to setting constraints, the exact dimensions of the germstones cannot be ascertained. Therefore, weights of the germstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the germstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
