Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's raised, 9ct yellow gold & gemstone set, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 1.77mm width (at base) x 1.25mm depth, with curved underrail, open back settings, underneath.

Feature, raised four claw setting to top, houses one oval-shaped, faceted natural emerald, claw set. The extended shoulders, taper up, split to three rails, centre rail each side contains four round brilliant cut diamonds, claw set.

Polished finish, stamped "375, .12ct JP42" - acid tested as 9 carat gold. Finger size = O.



The ring contains;

One claw set oval-shaped, faceted, natural emerald, colour is "dark - green".

Dimensions = 8.03mm (L) x 6.01mm (W) x 3.61mm (D-estimated)

Total Weight = 0.97ct (estimated - see NOTE below).

Eight claw set round brilliant cut diamonds, clarity is "P1", colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.48mm (average diameter) x 0.90mm (D-estimated)

Total Weight = 0.10ct (estimated - see NOTE below).

Total Item Weight = 3.08 grams, Total Gemstone Weight = 1.07ct, Total Metal Weight = 2.87 grams (estimated)

NOTE: Limited gemmological testing, inset. The natural emerald is heavily included with a surface reaching internal fracture visisble. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
