## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, sterling silver, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, half round band of 3.87mm width (at base) x 1.44mm depth.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the plain and polished band. Each of the extended and pointed shoulders, houses one row of four round brilliant cut diamonds, claw set.

Polished finish.

Unstamped - acid tested and x-rayed as silver.

Ring size: O 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P3", colour is "brown tint".

Dimensions = 4.68mm(Dia) x 2.4mm(D-estimated) x 1%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Eight claw set single cut diamonds, clarity is "P2 & P3" (mixed), colour is "brown tint".

Dimensions = 2.30mm (diameter) (smallest)

Dimensions = 2.50mm (diameter) (largest)

Total Weight = 0.40ct (estimated - see NOTE below)



Total Item Weight = 3.60 grams Total Gemstone Weight = 0.72ct Total Metal Weight = 3.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
