Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold & diamond set, multistone ring. Plain, wide, flat, low half round, tapered band, measures 3.74mm width (at base) x 0.90mm depth, with curved underrail, open back settings.

Feature; "duo row style" design. Comprising, a raised, rectangular-shaped white gold setting to top. Contains two beaded rows across the top. The extended shoulders, whoulder of the band, tapers up wide. Each shoulder terminates with a plain epaulette motif, to both sides.

Polished finish, stamped "18" - acid tested as 18 carat gold.

Finger size = N.

The ring contains;

Fourteen bead set round brilliant cut diamonds, clarity is "Si, P1, P2 & P3"(mixed), colour is "H to J"(mixed), medium cut quality.
Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (smallest)
Dimensions = 2.10mm (average diameter) x 1.28mm (D-estimated) (largest)
Total Weight = 0.28ct (estimated - see NOTE below).

Total Item Weight = 5.16 grams, Total Gemstone Weight = 0.28ct, Total Metal Weight = 5.10 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
