One lady's, hand finished raised, 9ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.85mm width (at base) x 0.92mm depth, with

Feature; "trilogy style", ring design. Comprising, a raised rub-over setting to centre, drops to each side, having a rub-over setting. The extended shoulders, of the band tapers up, & curls to each side of the central setting. Polished finish, stamped "?75" faded - acid tested as 9 carat gold.

One rub-over set round brilliant cut diamond, clarity is "P1", colour is "J to K" (mixed), medium cut quality.

Dimensions = 4.15mm (average diameter) x 2.53mm (D-estimated)

Total Weight = 0.25ct (estimated - see NOTE below).

Two rub over set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "J to K"(mixed), medium cut quality.

Dimensions = 2.14mm (average diameter) x 1.31mm (D-estimated)

Total Weight = 0.07ct (estimated - see NOTE below).

Total Item Weight = 3.12 grams, Total Gemstone Weight = 0.32ct, Total Metal Weight = 3.06 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
