## Valuation for Traditional Retail Insurance Replacement

## Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold & gemstone set, ring. Plain, wide, flat, tapered band, measures 3.28mm width (at base) x 0.73mm depth, with curved underrail.

Feature; "dress style" ring design. Comprising, raised 5 x four claw settings to top, in white gold. The extended shoulders of the yellow gold band, sweeps up to the top, from both sides.

Polished finish, stamped "18ct, 63977" - acid tested as 18 carat gold.

Finger size = N1/2.

The ring contains;

One claw set oval-shaped, faceted, natural garnet, colour is "dark reddish". Dimensions = 7.03mm (L) x 5.00mm (W) x 3.05mm (D-estimated) Total Weight = 0.89ct (estimated - see NOTE below).

Four claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality. Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest) Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest) Total Weight = 0.05ct (estimated - see NOTE below).

Total Item Weight = 3.69 grams, Total Gemstone Weight = 0.94ct, Total Metal Weight = 3.50 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
