## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand finished raised, 9ct yellow gold & gemstone set ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.59mm width (at base) x 0.75mm depth, with curved underrail.

Feature; "solitaire style" with shoulder stones. Comprising, a raised four claw setting to centre. The extended shoulders, of the band, tapers up, splits curl & wraps each side in channel set.

Polished finish, stamped "9K?" - acid tested as 9 carat gold. Finger size = N.

The ring contains;

One claw set oval-shaped, faceted, natural sapphire, colour is "light - pink".

Dimensions = 5.00mm (L) x 4.20mm (W) x 2.56mm (D-estimated)

Total Weight = 0.43ct (estimated - see NOTE below).

Ten claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)

Total Weight = 0.13ct (estimated - see NOTE below).

Total Item Weight = 2.14 grams, Total Gemstone Weight = 0.56ct, Total Metal Weight = 2.03 grams (estimated)

NOTE: Limited gemmological testing, inset. The sapphire is heavily included with a surface reaching internal fractures. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
