Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 10ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.88mm width (at base) x 0.94mm depth, with curved underrail.

Feature 'solitaire style' with shoulder stones. Comprising, a raised four claw illusion setting to top. The extended shoulders, of the band, tapers up to the top, each shoulder channel set.

Polished finish, stamped "10K, michael hill, 0.33TDW" - acid tested approximately 10 carat gold.

Finger size = P1/2.

The ring contains:

One illusion claw set round brilliant cut diamond, clarity is "P2", colour is "H", medium cut quality.
Dimensions = 3.50mm (Diameter) x 2.14mm (D-estimated)
Total Weight = 0.16ct (estimated - see NOTE below).

Ten channel set round brilliant cut diamonds, clarity is "P2", colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (smallest)
Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (largest)
Total Weight = 0.17ct (estimated - see NOTE below).

Total Item Weight = 2.29 grams, Total Gemstone Weight = 0.33ct, Total Metal Weight = 2.22 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
