Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 18ct yellow gold & gemstone set ring, of cast construction. Plain, narrow, low half round, tapered band, measures, 2.01mm width (at base) x 1.00mm depth, with cut-out underrail.

Feature; "solitaire style" with shoulder stones. Comprising, a raised semi rub-over setting to top. The extended shoulders, of the band tapers up, one side wraps around the central setting, the other side is channel set.

Polished finish, stamped "750, JAS, 750" - acid tested as 18 carat gold. Finger size = N.



The ring contains;

One rub-over set pear-shaped, faceted, synthetic emerald, colour is "dark - green".
Dimensions = 6.10mm (L) x 4.00mm (W) x 2.65mm (D-estimated)
Total Weight = 0.31ct (estimated - see NOTE below).

Four channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "I to J" (mixed), medium cut quality.
Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)
Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)
Total Weight = 0.05ct (estimated - see NOTE below).

Total Item Weight = 2.31 grams, Total Gemstone Weight = 0.36ct, Total Metal Weight = 2.24 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
