Valuation for Traditional Retail Insurance Replacement

Item 1

One hand finished raised, sterling silver & gemstone set ring, of cast construction. Plain, wide, half round, tapered band, measures 4.46mm width (at base) x 1.28mm depth, with curved underrail, open back central setting underneath.

Feature; "dress style" ring design. Comprising, a raised four claw square-shaped setting to top. The extended shoulders, of the band, tapers up to the top. Each shoulder has a single row, claw set, to both sides.

Polished finish, stamped "925" - acid tested as approximately sterling silver Finger size = W.



the ring contains;

One claw set round synthetic black moissanite, colour is "black opaque".

Dimensions = 5.98mm (average diameter) x 3.65mm (D-estimated) x 7%(Bulge)

Total Weight = 0.80ct (estimated - see NOTE below).

Six bead set Old Mine cut diamonds, clarity is "P2 & P3+"(mixed), colour is "I to K"(mixed), medium cut quality.

Dimensions = 2.00mm (average diameter) x 1.42mm (D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 8.28 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 8.08 grams (estimated)

NOTE: limited gemmological tested inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
