## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand crafted, 18ct yellow gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.11mm in width (at base) x 1.65mm depth, with open back settings.

Feature multi-claw ring design, housing five old cut and single cut (mixed) diamonds, tapering in size, claw set. Secured between the shoulders of the plain and polished band, with each shoulder having a 'scroll' design carving finish.



Polished finish.

Stamped 'W18D x 1' - acid tested as 18 carat gold.

Finger size is N.

The ring contains:

Five claw set old cut & single cut (mixed) diamonds, clarity 'Vs, Si & P1' (mixed), colour 'I & K to L' (mixed).

Dimensions = 1.80mm(Dia) x 1.28mm(D-estimated) (smallest)

Dimensions = 2.16mm(Dia) x 1.53mm(D-estimated) (largest)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 3.15 grams

Total Gemstone Weight = 0.16ct

Total Metal Weight = 3.12 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
