Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold, platinum (mixed) & diamond set, ring. Plain, narrow, low half round, tapered band, measures 2.23mm width (at base) x 1.37mm depth, with open back, underneath.

Feature: "cluster style" ring design, with shoulder stones. Comprising, a raised, open cluster vintage style to top in white metal, scalloped edge, housing thirteen old mine cut diamonds, bead set. The extended shoulders, of the yellow gold band, tapers up to the top, with pointed end terminations to both sides.



Polished finish, stamped "X,18,ship, Plat" - acid tested & x-rayed. scratched 7547.

Finger size = Q.

The ring contains;

Thirteen bead set Old Mine cut diamonds, clarity is "Si & P1"(mixed), colour is "I to K"(mixed), medium cut quality.

Dimensions = 1.87mm (average diameter) x 1.33mm (D-estimated) (smallest)

Dimensions = 2.03mm (average diameter) x 1.44mm (D-estimated) (largest)

Total Weight = 0.33ct (estimated - see NOTE below).

Total Item Weight = 3.23 grams, Total Gemstone Weight = 0.33ct, Total Metal Weight = 3.17 grams (estimated)

NOTE:Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
