Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 9ct yellow gold & diamond set, three stone ring. Plain, narrow, low half round, tapered band, measures 1.38mm width (at base) x 0.71mm depth, with cut-out underrail.

Feature; "trilogy style" ring design. Comprising, three rub-over setting to top, with open backs underneath. The extended shoulders, of the band tapers up to the top, from both sides.

Polished finish, stapmed "375, GM16" - acid tested as 9 carat gold.

Finger size = Q.

The ring contains;

Three rub-over set round brilliant cut diamonds, clarity is "Si", colour is "brown tint", medium cut quality. Dimensions = 3.43mm (average diameter) x 2.09mm (D-estimated) (smallest) Dimensions = 3.92mm (average diameter) x 2.50mm (D-estimated) (largest) Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 2.14 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.04 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
