Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, single stone design, diamond set ring, of cast construction.

Plain, narrow, tapered band of 2.94mm in width (at base) x 0.95mm depth, with hollow top and shoulders, and open back setting.

Feature single stone ring design, housing one Princess cut diamond, tension set.

Polished finish.

Stamped '750 18K(partial) and P(partial)' - acid tested as 18 carat gold.

Finger size is S.

The ring contains:

One tension set Princess cut diamond, clarity 'Vs2', colour 'G'.

Dimensions = 4.32mm(L) x 4.30mm(W) x 3.25mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 3.83 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 3.73 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
