## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 10ct yellow gold and 10ct white gold, diamond set pendant.

Feature hollow and open back, articulated 'heart' design, housing a total of one hundred and seven tapered baguette cut diamonds, tapering in size, claw set.

Articulated from the yellow gold tapering bail assembly.

Polished finish - stamped '10K ZRW with copyright symbol' - acid tested as approximately 10 carat gold.

Pendant dimensions = 30.00mm (length including bail) x 25.00mm (ave. width).

The pendant contains:

- One Hundred And Seven claw set tapered baguette cut diamonds, clarity 'Si, P1 to P3' (mixed), colour 'H to I' (mixed).
- Dimensions = 1.30mm(L) x 0.50mm(W) x 0.20mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 1.80mm(L) x 1.30mm(W) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 3.96 grams  
Total Gemstone Weight = 1.00ct  
Total Metal Weight = 3.76 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
