## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 10ct yellow gold and 10ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 8.82mm at top to 2.34mm in width (at base) x 0.88mm depth, with hollow top and shoulders, and open back settings.

Feature central white gold five 'cluster' style, bar divided settings, each housing nine round brilliant cut diamonds, tapering in size, claw set. The outer rows of the yellow gold plain and polished band, having seventeen round brilliant cut diamonds, tapering in size, claw set.



Polished finish.

Stamped '10K MHJ' - acid tested as approximately 10 carat gold.

Finger size is R.

The ring contains:

Seventy Nine bead set round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'H to J' (mixed).

Dimensions = 0.80mm(Dia) x 0.49mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 4.21 grams Total Gemstone Weight = 1.00ct

Total Metal Weight = 4.01 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
