Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold, multistone, gem set ring, of cast construction.

Plain, wide, tapered band of 3.88mm in width (at base) x 1.28mm depth, with open back (drilled) settings.

Feature 'cross-over' style ring design, housing seven round brilliant cut diamonds

Polished finish.

Stamped '10K MHJ' - acid tested as approximately 10 carat gold.

Finger size is T 1/2.

The ring contains:

Seven channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).
Dimensions (average) = 2.50mm to 2.70mm (Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 7.87 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 7.77 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
