## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold/palladium, multistone, gem set ring.

Plain, narrow, tapered band of 2.93mm in width (at base) x 0.83mm depth, with a curved underrail.

Feature central white gold/palladium six claw setting, consisting of an illusion plate, housing one round brilliant cut diamond, illusion set. Each extended and upswept shoulder, with 'U' central section having a white gold/palladium top plate terminations, each claw set with two single cut diamonds.



Polished finish - stamped '750 Pd' - acid tested. Finger size is N.

The ring contains:

One illusion set round brilliant cut diamond, clarity 'Si', colour 'G'.

Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.05ct (estimated - see NOTE below)

Four claw set single cut diamonds, clarity 'Si', colour 'G to H' (mixed).

Dimensions = 1.30mm (average diameter)

Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 4.52 grams - Total Gemstone Weight = 0.09ct - Total Metal Weight = 4.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
