## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 10ct rose gold, dress style, gem set ring, of cast construction.

Plain, narrow band of 2.12mm in width (at base) x 1.23mm depth, with open back setting.

Feature central railed bezel setting, housing one oval-shape cabochon cut natural opal, rub-over set. To each compass point is a three claw setting, claw set with one round brilliant cut diamond. All secured between the shoulders of the plain and polished band.

Polished finish - stamped '417 michael hill' - acid tested as approximately 10 carat gold. Finger size is O.

The ring contains:

One claw set oval-shape cabochon cut solid light opal with mixed pattern of red, orange, yellow, green, blue & violet play of colours.  
Dimensions = 8.85mm(L) x 6.65mm(W) x 2.82mm(D-estimated)

Four claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'I to J' (mixed).  
Dimensions (average) = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.07ct (estimated - see NOTE below)

Total Item Weight = 2.47 grams.

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The opal top has some scratches and abrasion and can be repolished. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
