## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 9ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, wide, tapered band of 11.80mm at top to 4.24mm in width (at base) x 1.24mm depth, with hollow top and shoulders, and open back settings.

Feature multi-row, 'cross-over' style ring design, consisting of two rows, housing a total of twenty round brilliant cut diamonds, channel set. Alternating with three rows, pave' set with a total of thirty-two round brilliant cut diamonds. The shoulders of the yellow gold plain and polished band having a multi-grooved finish.

Polished finish - stamped '9K' - acid tested as 9 carat gold. Finger size is N.

The ring contains:

Twenty channel set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'brown'. Dimensions (average) = 2.05mm(Dia) x 1.25mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.60ct (estimated - see NOTE below)

Thirty Two pave' set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to H' (mixed). Dimensions (average) = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 5.12 grams - Total Gemstone Weight = 0.80ct - Total Metal Weight = 4.96 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
