## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.02mm in width (at base) x 1.10mm depth, with hollow and open back setting.

Feature central four claw setting, housing one square cushion cut natural aquamarine, claw set. Surrounded by twenty round brilliant cut diamond (smallest), claw set. The setting sides of a pierced design, all secured between the shoulders of the plain and polished band. Each shoulder having eight round brilliant cut diamonds, claw set.

Polished finish - stamped '750 D' - acid tested as 18 carat gold. Finger size is U.

The ring contains:

One claw set mixed cut square cushion cut natural aquamarine, colour 'medium light blue'.  
Dimensions = 7.11mm(L) x 6.98mm(W) x 4.10mm(D-estimated)  
Total Weight = 1.33ct (estimated - see NOTE below)

Thirty Six claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).  
Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)  
Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)  
Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 3.70 grams - Total Gemstone Weight = 1.73ct - Total Metal Weight = 3.35 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
