## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow band of 1.92mm in width (at base) x 1.27mm depth, with open back settings.

Feature single row spanning across the top of the plain and polished band, housing thirteen round brilliant cut diamonds, claw set.

Polished finish.

Unstamped.

Stamped '375 JP88' - acid tested as 9 carat gold.

Finger size is O.

The ring contains:

Thirteen claw set round brilliant cut diamonds, clarity 'Si, colour 'I to J' (mixed).

Dimensions (average) = 1.95mm(Dia) x 1.19mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 1.91 grams

Total Gemstone Weight = 0.36ct

Total Metal Weight = 1.84 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
