## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand crafted, 18ct yellow gold and platinum, multistone, gem set ring.

Plain, narrow, tapered band of 1.58mm in width (at base) x 0.86mm depth, with a curved underrail, and open back (drilled) at shoulders.

Feature central six claw setting with illusion plate, housing one early brilliant cut diamond, illusion set. Each shoulder plate of a 'leaf' style, bead set with four single cut diamonds each side. All mounted atop the yellow gold plain and polished band.



Polished finish - stamped '18CT PLAT' - acid tested. Finger size is N 1/2.

The ring contains:

One illusion set early brilliant cut diamond, clarity 'P1', colour 'G'.

Dimensions = 4.08mm(Dia) x 2.57mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.25ct (estimated - see NOTE below)

Eight bead set single cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).

Dimensions = 1.15mm (average diameter)

Total Weight = 0.05ct (estimated - see NOTE below)

Total Item Weight = 3.10 grams - Total Gemstone Weight = 0.30ct - Total Metal Weight = 3.04 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
