Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of hand-assembled, 18ct yellow gold and 9ct yellow gold, gem set earrings.

Feature 18 carat yellow gold half hoop style earring design, each consisting of three marquise cut natural sapphires, two claw set, alternating with two round brilliant cut diamonds, four claw set. The settings finishing with a 'curled' termination.

Post fittings, with 9 carat yellow gold butterflies fitted.

Polished finish.

Stamped '375' (on butterflies) - acid tested as 18 carat gold (earrings) & 9 carat gold (butterflies).

Earring dimensions = 19.20mm (ave. length) x 14.20mm (width) x 2.45mm (depth).

The earrings contain:

Six claw set mixed cut marquise cut natural sapphires, colour 'dark blue'.
Dimensions (average) = 4.31mm(L) x 2.32mm(W) x 1.40mm(D-estimated)
Total Weight = 0.66ct (estimated - see NOTE below)

Four claw set round brilliant cut diamonds, clarity 'Si', colour 'H to I' (mixed).
Dimensions (average) = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 2.81 grams - Total Gemstone Weight = 0.80ct - Total Metal Weight = 2.65 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
