## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand-assembled raised 9ct & 18ct white gold & diamond set, pendant/necklet.

Feature; "circular-shaped" drop style pendant, in 9ct white gold, with an open geometric pattern to centre, housing sixty eight round brilliant cut diamonds, claw set, Attached to top, a fixed v-shaped bail with a round brilliant cut diamond, claw set. Suspended from an 18ct white gold extender style cable linked chain, with a silicon ball shortner & heart motif one end, attached a parrot clasp closure, to the other end.

Polished finish, stamped "VC 9ct (pendant), 750 Italy (extender chain)" - acid tested both.  
Pendant dimensions = 33.00mm (total length) x 20.50mm (width) x 2.78mm (depth).  
Chain dimensions = 41.00cm (total length) x 0.80mm (width) x 0.80mm (depth).

The pendant contains:

Sixty Nine claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.  
Dimensions = 1.46mm (average diameter) x 0.89mm (D-estimated) (smallest)  
Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (largest)  
Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 8.42 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 8.22 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar pendant/chain combo employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
