## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.12mm in width (at base) x 0.88mm depth.

Feature white gold settings, consisting of three individual four claw railed settings, each housing one round cut and faceted natural sapphire, slightly varying in size, claw set. Alternating with four single cut diamonds, bead set in groups of two, in rectangular-shape, individual settings with millegrain edging. Each shoulder having a white gold laid-on curved plate, all secured atop the yellow gold plain and polished band.

Polished finish - stamped '18CT A&C' - acid tested as 18 carat gold. Finger size is O.

The ring contains:

Three claw set round cut and faceted natural sapphires, colour 'dark blue'.  
Dimensions = 2.90mm to 3.00mm(Dia) x 1.80mm(D-estimated) x 2%(Bulge)  
Total Weight = 0.36ct (estimated - see NOTE below)

Four bead set single cut diamonds, clarity 'Si', colour 'H to I' (mixed).  
Dimensions = 1.25mm (ave. diameter)  
Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 4.10 grams - Total Gemstone Weight = 0.40ct - Total Metal Weight = 4.02 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
